

**A RESOLUTION ESTABLISHING A SCHEDULE OF REGULAR MEETINGS
FOR THE BOARD OF TRUSTEES OF THE VILLAGE OF THOMASBORO
FOR THE CALENDAR YEAR 2014**

WHEREAS, Section 2.02 of the Illinois Open Meetings Act, 5 ILCS 120 *et seq.* (the “Act”) provides that every public body shall give public notice of the schedule of regular meetings at the beginning of each calendar or fiscal year and shall state the regular dates, times and places of such meetings; and

WHEREAS, Section 2.03 of the Act provides that each public body subject to the Act must prepare and make available a schedule of all its regular meetings for such calendar or fiscal year; and

WHEREAS, the Village of Thomasboro (the “**Village**”) is a public body subject to the requirements of the Act;

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF THOMASBORO, CHAMPAIGN COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: The facts and statements set out in the preamble to this Resolution are hereby found by the Board of Trustees of the Village to be true and correct and are hereby adopted and incorporated as part of this Resolution.

Section 2: The schedule of regular meetings of the Board of Trustees of the Village for the calendar year 2014 shall be as set forth on “Schedule A” attached hereto and made a part hereof as if fully set forth. All regular meetings of the Board of Trustees of the Village shall be held at **Thomasboro Village Hall, 101 West Main Street, Thomasboro, Illinois 61878**, and shall convene at the hour of **7:00 P.M.**, local time.

Section 3: Notice of such regular meetings and the schedule of meetings attached hereto shall be given by the Village Clerk to all news media that have filed an annual request for such notice with the Village.

Section 4: This Resolution shall be in full force and effect from and after its passage.
